## Notice Concerning Difference Between Earnings Forecasts and Actual Results

Nishi-Nippon Railroad Co., Ltd. (the "Company") hereby announces the following regarding the difference between the consolidated earnings forecast for the first six months (interim period) of the fiscal year ending March 31, 2026, announced on May 9, 2025, and the actual results announced today.

## (Reasons for difference)

Operating revenue fell short of the previous forecast, mainly due to the timing of sales of some rental condominium units sold as one building in the Housing business moved to the second half of the year.

Operating income exceeded the previous forecast due to lower than initially expected personnel expenses, etc. in the Transportation business and Leisure & Service business as well as the occurrence of some expenses in the Real Estate business moved to the second half of the year or later.

Ordinary income exceeded the previous forecast due to an increase in operating income and an improvement in share of profit of entities accounted for using the equity method.

Interim profit attributable to owners of parent exceeded the previous forecast, mainly due to an increase in gain on sales of investment securities.
